Federal Tax Deadline Extended to July 15th and Other Updates By Scott Kaup

Information is coming at the speed of light, but we wanted to give you the latest information as of today. I just got off the phone with a representative from Senator Deb Fischer's office who called to see what we felt was needed. I mentioned that in addition to providing SBA forgivable loans to businesses who continue to pay their employees, that a tax credit would accomplish the same thing for employers and save them and the banks from a crush of SBA loans. He also expressed their dissatisfaction that the senate bill proposed yesterday did not pass. It is hopeful that something will be completed this week and when it does, we will forward you more specific information.

IRS and State of Nebraska Extend Tax Filing Deadline to July 15th, 2020

The IRS and State of NE have extended the filing deadline from April 15th to July 15th. This means that you have until July 15th to file AND pay your 2019 federal income tax liability. They have also extended the deadline to make your April 15th quarterly estimated payments to June 15th.

Financial Assistance for Individuals

As of this writing, the senate is in negotiations on a bill that *could* provide cash payments to individuals. The most recent proposal *could* provide up to \$1,200 per adult and up to \$500 per child. There is likely to be an income threshold. Of course, this is a fluid situation with legislators still actively negotiating the finer points of the bill. We will update as soon as final information comes out.

Unemployment Insurance

If you have lost your job, you need to apply online for unemployment insurance now. On Tuesday, Governor Ricketts announced that from March 22 through May 2, NDOL would be waiving the requirement to search for work, as well as the requirement to serve an unpaid waiting week once eligibility is determined. Currently you cannot be paid any benefit for lost wages before the date you apply. You will need to create an account here: https://neworks.nebraska.gov/vosnet/loginintro.aspx

Financial Assistance for Small Businesses

SBA Loans

There is currently talk of direct assistance to both affected business and possibly all businesses with under 500 employees. Our government leaders understand the importance of providing assistance for our small businesses to be able to continue paying employees and provide cash flow assistance. It appears likely that there will be SBA loans that would be forgiven if used for payroll and other overhead expense. Hopefully we will have specifics this week.

Short-Time Compensation

In addition to regular unemployment insurance benefits, employers also have the option of utilizing Short-Time Compensation (STC). The Short-Time Compensation program helps prevent layoffs by allowing employers to uniformly reduce affected employees' hours by 10 to 60 percent while permitting the employees to receive a prorated unemployment benefit.
